3a Evidence for Policy C! Community facilities

Community facilities in neighbourhood plans are defined: Where proposals for developments would result in the loss of any of the following existing facilities or services, satisfactory alternative provision should be made within the community if a sufficient level of need is identified.

BM introduced two documents – **Part 1** contains the evidence for the list of Community Facilities:

- Hyde Park Surgery
- Park Dale Hall (Marlboroughs)
- Post Office, Woodsley Road
- Rosebank Primary and Nursery School
- Swarthmore Education Centre
- Woodsley Community Centre.

The second document has two more parts:

Part 2 is a summary of the Walkable

Neighbourhood framework of local facilities

applied to Little Woodhouse. (Based on the Mott

MacDonald study for LCC, 2022, part of the

Technical Report for the Local Plan Update.)

Part 3 contains a list of facilities prepared and

presented to the Forum in 2024.

Discussion points:

- Pubs had been removed following comments from LCC that these were covered by licensing regulations
- PB noted that pubs had been included in the Holbeck NP. Several members

remarked on their importance for social cohesion.

- Noted that the Highland pub has recently re-opened. Other well used pubs include the Kirkstall Brewery, Archive Bar, Fox and Newt and other restaurant/bars. Agreed to add paragraph to note this in the evidence paper.
- Higher Education this category had been added following the discussion of the last forum. Because of the significance of the University to the area, including as a landlord, this should be highlighted in the evidence.
- Places of worship this category should be highlighted as important for social cohesion, not only for this area, but for other communities across the city.
- Problem of unavailability of the Park Dale Hall. Owned by the Council but not enough resources to re-open. PB pointed out that the NPplan has to run until 2033 and circumstances could change and we would like to keep it in use.
- DP reported that a recent discussion about the proposed Leeds List was to be based on a list of all public buildings.
- GR asked about the future demand for GP and Schools with the developments south of Kirkstall Road. DP said this should be flagged up with the West End Riverside design team which is attending the next Community Forum on 8 July 2025
- Nurseries should include the LGI, Univ creches
- Include Swarthmore café and Hyde Park Picture House.
- Car parking MP reported that due to the recategorizing of the Josephs Well carpark as commercial, incurring rates charges, there would be a loss of free parking there.

DP asked for the approval of the meeting for this approach to the evidence paper. It was agreed.

3b Progress on the Neighbourhood Plan

PB reported that the discussions with Leeds City Council had been completed: KS had been very helpful in drawing together feedback from several departments. The working group (PB DP BM) had also had a very constructive meeting with Kate Newell of the Conservation Team.

Discussion with Kate Newell had centred on the differences between NDHAs and positive buildings. An NDHA was usually where original features had survived: where there were alterations e.g. large dormers, the building could be classified as a positive building, and the area or setting could also be seen as either NDHA or positive. A map has been drawn up with all these illustrated and a list of the detailed descriptions. Example: NDHA - 9-13 Claremont Grove have retained original windows and dormers; 1-7 and 2-6 Claremont Grove positive buildings because of alterations to windows and cellars, but nevertheless contribute to the setting. DP reported that the discussion he had attended had also focused on settings as well as buildings.
